MIGS Raw Label Material Limited Warranty, Disclaimer, and Waiver of Claims (pre-application)

Thank you for purchasing a MOLD IN GRAPHIC SYSTEMS® Label Product (herein after referred to as the "Product"). We are pleased to present you with this Raw Label Limited Warranty, Disclaimer, and Waiver of Claims ("Limited Warranty").

The terms of this Limited Warranty state the entire obligation of Joram Corporation, dba MOLD IN GRAPHIC SYSTEMS® (herein after referred to as "MOLD IN GRAPHIC SYSTEMS®"), or its successor and assigns with respect to the Product. The Product is warranted only against any manufactured defects as described below within twelve (12) months from the date of shipment. The remedies under this Limited Warranty against manufactured defects are strictly limited to replacement of the Product.

For the purposes of this Limited Warranty being provided to you (referred to herein as "Buyer"), the Product is supplied as a raw material component which is applied to a rotational mold or a polyolefin product by Buyer. MOLD IN GRAPHIC SYSTEMS® provides a full warranty that the Product meets technical specifications as tested and qualified by Buyer at the time of delivery.

Should the Product fail to meet the technical specifications within 12 months of the manufacture date and prior to application, MOLD IN GRAPHIC SYSTEMS® will immediately replace, at its expense, the non-complying Product, provided that the Product had been stored in accordance with the following MOLD IN GRAPHIC SYSTEMS® climate-controlled environment storage requirements:

The Product should not be pressed or stacked upon.

The Product should be stored at a temperature between 10c – 35c (50F – 95F).

The Product should not be stored in direct sunlight.

Partially used Product needs to be placed in a protective storage container.

In the event these requirements are not followed, this Limited Warranty is void. To prove that the Product does not comply with the technical specifications, Buyer must, in writing within 12 months of the delivery date and prior to application, provide MOLD IN GRAPHIC SYSTEMS® the Item Code, Item Description, PO Number and ID Number affixed to packaged Product bundles delivered to Buyer, and prove that the storage requirements have been met.

The Product is made from polyolefin materials. Successful application of the Product requires that three application components (e.g. label transfer pressures, rotational mold/polyolefin product conditions, and

cure cycle times & temperatures) be in compliance with MOLD IN GRAPHIC SYSTEMS® technical specifications for proper application that results in complete fusion of label to substrate. Buyer understands that these settings impact Product performance. Upon request, MOLD IN GRAPHIC SYSTEMS® will provide free phone and/or email technical assistance to Buyer on the proper application of the Product. On-site assistance is also available at a mutually agreeable fee to Buyer.

The durability of Mold In Graphic Systems[®] lineup of permanent labels for polyolefin durable goods, hereby referred to as "*MIGS® Labels", for polyolefin Durable Goods Products has been verified through years of lab testing and real world examples, including weatherability and chemical and abrasion testing according to ASTM procedures (Test Data Report Available Upon Request). Assuming any MIGS® Label, which has been kept in accordance with MIGS® Raw Label Limited Warranty (shown above), is properly applied by the customer, Mold In Graphic Systems® warrants that the legibility and print quality of its label will outperform other labels available today for polyolefin plastic durable goods (normal wear and tear excepted including normal discoloration and fade due to atmospheric conditions), for the "**normal service life" of the product from the date of application under normal and intended use and service conditions. This warranty is expressly limited to any applied MIGS® Label that is proven to be defective in material and/or workmanship to the satisfaction of Mold In Graphic Systems®. If the applied MIGS® Label fails to meet the warranty criteria of good commercial legibility and print quality under normal conditions, the customer must timely notify Mold In Graphic Systems® of any claimed defects and provide proof of the allegedly defective label to Mold In Graphic Systems® for inspection. If the applied label is determined defective, Mold In Graphic Systems® will provide the customer with label credit or a replacement label at no charge for the customer to re-install and/or place over the defective part in question as an alternative to molding another part.

If MIGS® sells or provides prototypes or samples to Purchaser, such prototypes or samples shall not be covered by these terms and conditions, are sold or provided "as is" with no warranties whatsoever, and shall not constitute the basis of any present or future warranty from MIGS®.
